The battery must be firmly packed in inner packaging so as to effectively prevent short circuits and short circuits caused by movement. If the electrolyte leaks, avoid directly contacting with eyes and skin. Avoid inhalation. Incompatibilities: Strong oxidizing agents, combustible materials and corrosives.

Conditions for Safe Storage, Including Any Incompatibilities:


